PRIVACY POLICY

www.inspiredcrew.com (our website) is provided by Inspired Crew Ltd ('we', 'our' or 'us'). We are the controller of personal data obtained via our website, meaning we are the organisation legally responsible for deciding how and for what purposes it is used.

Please read this privacy policy carefully as it contains important information on who we are and how and why we collect, store, use and share any information relating to you (your personal data) in connection with your use of our website. It also explains your rights in relation to your personal data and how to contact us or a relevant regulator in the event you have a complaint.

We collect, use and are responsible for certain personal data about you. When we do so we are subject to the UK General Data Protection Regulation (UK GDPR). We are also subject to the EU General Data Protection Regulation (EU GDPR) in relation to goods and services we offer to individuals in the European Economic Area (EEA).

What this policy applies to

This policy relates to how we collect personal data from you - in person, by telephone, text or email and/or via our Website.

Personal data we collect about you

The personal data we collect about you depends on the particular activities carried out. We may collect and use the following personal data about you:

- Name and contact information, including email address and telephone number
- Nationality
- Date of Birth
- Your personal or professional interests
- Your professional online presence, eg LinkedIn profile
- Information about how you use our website, IT, communication and other systems

We collect and use this personal data for the purposes described in the section 'How and why we use your personal data' below.

Personal data provided by you

As part of the recruitment process, we may ask you for further personal information in order to perform our services. We may request the following from you:

- Professional Qualifications
- Safety Certificates STCW95/2010
- ENG1 medical
- CV (including employment history)
- Job preferences, including role, geographical locations and salary
- References
- Details of education
- Passport / Visa's
- Seamans Discharge Book
- Current Location
- Criminal record checks and security clearance for certain positions
- Anything specific requested by a potential employer

The legal basis for us collecting and holding this data is legitimate business interest and we will hold this data in line with our retention policy.

Third Parties

We may also collect data from third parties including but not limited to:

LinkedIn and other social media sites

- References
- Referrals

The legal basis for us collecting and holding this data is a legitimate business interest and we will hold this data in line with our retention policy.

Non-Personal Information

We may also collect non-personal information, such as website usage data, IP address, geographical location, length of visit, browser type, and operating system, to analyse user behaviour, to optimize website use and enhance security.

How your personal data is collected

We collect most of this personal data directly from you—in person, by telephone, text or email and/or via our website. However, we may also collect information directly:

- from a third party with your consent
- from cookies on our website—for more information on our use of cookies, please see our cookie
 policy
- via our IT systems.

We collect personal data from you:

- directly, when you enter or send us information
- indirectly, such as your browsing activity while on our website; we will collect information indirectly using the technologies explain in the section on 'Cookies below.

How and why we use your personal data

We collect basic personal information relating to our recruitment services. We ask for more detailed information as part of the recruitment process to assess your eligibility for a role, including previous work experience and geographic location.

Under data protection law, we can only use your personal data if we have a valid reason, eg:

- where you have given consent
- to comply with our legal and regulatory obligations
- for our legitimate interests or those of a third party

A legitimate interest is when we have a business or commercial reason to use your information, so long as this is not overridden by your own rights and interests. We will carry out an assessment when relying on legitimate interests, to balance our interests against your own. You can obtain details of this assessment by contacting us (see 'How to contact us' below).

We use your personal data for:

providing services to you

- customise our website and its content to your particular preferences based on a record of your selected preferences or on your use of our website
- communications with you not related to marketing, including about changes to our terms or policies or changes to the services or other important notices
- updating and enhancing customer records
- marketing our services to existing and former customers
- protecting the security of systems and data
- to enforce legal rights or defend or undertake legal proceedings
- external audits and quality checks, eg for the audit of our accounts

See 'Who we share your personal data with' for further information on the steps we will take to protect your personal data where we need to share it with others.

Marketing

We may use your personal data to send you updates (by email, text message, or telephone) about our services, including exclusive offers, promotions or new services. We have a legitimate interest in using your personal data for marketing purposes (see above 'How and why we use your personal data'). This means we do not usually need your consent to send you marketing information. However, where consent is needed, we will ask for this separately and clearly.

You have the right to opt out of receiving marketing communications at any time by contacting us at info@inspiredcrew.com.

We may ask you to confirm or update your marketing preferences if you ask us to provide further services in the future, or if there are changes in the law, regulation, or the structure of our business.

We will always treat your personal data with the utmost respect and never sell it with other organisations for marketing purposes.

For more information on your right to object at any time to your personal data being used for marketing purposes, see 'Your rights' below.

Who we share your personal data with

As a recruitment agency our role is to share candidate information with prospective employers with your consent. Outside of this, we will only share personal information with others when we are legally permitted to do so. We do not sell your data to any third parties.

Collection of data alone does not permit us to send information third parties. In order to perform our recruitment services, we will ask for your permission in order to share information to third parties as part of the recruitment process, including passing candidate details to prospective employers.

We routinely share personal data with:

- third parties we use to help deliver our services to you; and
- other third parties we use to help us run our business, eg website hosts and website analytics providers.

We or the third parties mentioned above may occasionally also need to share personal data with external auditors, eg in relation to the audit of our accounts, in which case the recipient of the information will be bound by confidentiality obligations.

How long your personal data will be kept

We will not keep your personal data for longer than we need it for the purpose for which it is used.

We have a legitimate business interest to keep your personal information securely stored for as long as we need it to provide you with the services you want from us.

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. Our standard retention period for potential candidate data is 7 years.

When deciding what the correct time is to keep the data, we look at its amount, nature and sensitivity, potential risk of harm from unauthorised use or disclosure, the processing purposes, if these can be achieved by other means and legal requirements.

In some circumstances we may anonymise your personal data for research or statistical purposes in which case we may use this information indefinitely without further notice to you.

Transferring your personal data out of the UK and EEA

The EEA, UK and other countries outside the EEA and the UK have differing data protection laws, some of which may provide lower levels of protection of privacy.

It is sometimes necessary for us to share your personal data to countries outside the UK and EEA. In those cases we will comply with applicable UK and EEA laws designed to ensure the privacy of your personal data.

Under data protection laws, we can only transfer your personal data to a country outside the UK/EEA where:

- in the case of transfers subject to UK data protection law, the UK government has decided the
 particular country ensures an adequate level of protection of personal data (known as an 'adequacy
 regulation') further to Article 45 of the UK GDPR;
- in the case of transfers subject to EEA data protection laws, the European Commission has decided that the particular country ensures an adequate level of protection of personal data (known as an 'adequacy decision') further to Article 45 of the EU GDPR;
- there are appropriate safeguards in place, together with enforceable rights and effective legal remedies for you, or
- a specific exception applies under relevant data protection law.

Where we transfer your personal data outside the UK we do so on the basis of an adequacy regulation or (where such is not available). The company will take steps necessary to ensure your data is treated securely and in accordance with this privacy policy and will not transfer your personal data to an organisation or country unless there are adequate security controls in place.

Any changes to the destinations to which we send personal data or in the transfer mechanisms we use to transfer personal data internationally will be notified to you in accordance with the section on 'Change to this privacy policy' below.

Cookies

A cookie is a small text file which is placed onto your device (eg computer, smartphone or other electronic device) when you use our website. We use cookies on our website.

For further information on cookies, please see our cookie policy.

Your rights

You generally have the following rights, which you can usually exercise free of charge:

- access to a copy of your personal data
- correction (also known as rectification) if you see a mistake in your personal data
- erasure (also known as the right to be forgotten) if you require us to delete your personal data in certain situations
- restriction of use if you require us to restrict use of your personal data in certain circumstances, eg if you contest the accuracy of the data
- data portability, the right to receive the personal data you provided to us, in a structured, commonly
 used and machine-readable format and/or transmit that data to a third party—in certain situations
- the object to use at any time to your personal data being used for direct marketing
- not to be subject to decisions without human involvement is your right not to be a subject to a decision based solely on automated processing

Keeping your personal data secure

We have appropriate security measures to prevent personal data from being accidentally lost, or used or accessed unlawfully. We limit access to your personal data to those who have a genuine business need to access it.

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

How to complain
